

Pinellas County School Superintendent Michael Grego was presented with the Silver Good Citizenship medal by Chairman Butler.

Guest Speakers

Dr. Grego began his career as a teacher in Hillsborough County, and was the superintendent for Osceola County before reaching his current position. He appreciates and encourages our involvement in the support of teaching history in our high schools. He cited numerous examples of the progress being made in our schools:

Graduation rates are up significantly in recent years, including for minorities.

The IB program at St. Petersburg High School was the first in the southeast, and had a 100% diploma rate last year. School safety programs have increased. Over the past five years the number of AP exams taken grew by 57%, with 51% achieving a qualifying score of 3 or higher. College credits

earned yield over \$12 million in annual savings for parents. Career and technical programs have produced over 13 thousand certifications, with a 96% graduation rate.

Professor Phillip Leto gave a lively presentation on the presidents, the Constitution, and the growth of the country. After the ratification in 1789, 12 amendments were proposed in 1791, but two did not pass. The founders wisely required amendments to pass with a 2/3 majority in each house of Congress, and then to be approved by 75% of the state legislatures. One of the failed amendments involved reapportionment, and the second would allow Congress to increase their own salaries. The latter was not approved until 1992.

FLSSAR Regional VP Dick Young told the chapter about the "partners in patriotism" program, which supports the honor flights, wreath ceremonies and similar events. Our chapter currently participates in these events. He is also the FLSSAR CAR liaison. Compatriot Young said that NSSAR is working on a patriot research system for online use. Florida will host the 2023 National SAR Congress meeting, likely in Orlando. John Stewart stated that this year's essay contest winner will be attending the May meeting, and receive his award. John was a judge for the recent Pinellas County "national history day." There were over 200 exhibits but none qualified for our award, which is based on events surrounding the founding of our country.

Guest Speaker

Lori Coffey's presentation topic was "the women of 1620." She spoke at length about each of the four women who survived the first year at Plymouth. There were 102 people on the Mayflower, but only the men were named in the ship's log: "John Smith and wife and son." The pilgrims were of two factions – the "saints" who sought religious freedom, and the "strangers" who sought prosperity. The women had no rights then, as widows were forced to remarry, and sign their assets over to their husbands. Everyone became a farmer in Plymouth by necessity, as they couldn't own land back in England.

April 2019

Officer Reports & Presentations

John Stewart presented our chapter with a streamer for our participation in a ceremony commemorating the battle of Thomas Creek in northeast Florida, in which militia members were attacked in 1777 by Loyalists, British soldiers, and Creek Indians. It is considered the only Revolutionary War battle in Florida.

Charles Butler updated the members on our Education Initiative. We are working with the Tampa chapter, with support from several DAR chapters. The initial meeting will be on April 26. Our September 14 meeting will include a presentation by Joseph Hardesty, the NSSAR library director, on the US census and family research.

Guest Speakers

After introductory comments by SSgt. Johnson, Sgt. Defoore spoke about their role as Marine recruiters in Pinellas County. Their challenge is "finding our replacements." There are 360 different job classifications, including photography, technology, medical, and legal. The public is focused on warfare, and often overlooks the benefit of four years of paid college. He also noted that some high schools are more "open" to military recruiting visits than others.

Since the Fall BOM, your Treasurer has:

- ➤ Participated, as part of the Florida SAR State Color Guard at the commemorations of the Last Naval Battle (March 9) and the Battle of Thomas Creek (March 30)
- Represented the Florida SAR at the Annual Conference of the Florida Society of the Children of the American Revolution (February 22-24)
- Filed the necessary IRS Forms 1099 for those award winners who received more than \$600 from the Florida SAR. The IRs Form 990 EZ is due on May 15 and will be filed on or before the due date. If completed and filed prior to this BOM, a copy will be available for your inspection. A copy of the IRS 990, as filed, will also be posted under the Members

section on the Florida SAR website.

Liability Insurance

Since the Fall of 2017, I have been seeking information and quotes on General Liability and Directors and Officers Insurance for the Florida Society. The impetus for the coverage was two-fold: 1) recent events (at the time) within FLSSAR where a member was threatening lawsuit, 2) insured protection from cost of litigation for allegations of sexual misconduct by an SAR member on SAR business. I worked with two different brokers in the Tampa area that I had worked with previously and I found a third carrier that serves only non-profit organizations. Over time all three of these possibilities either declined to quote or could not find a quote for less than \$10,000/year. It was our discussion of black powder salutes at SAR events that caused their reluctance to provide coverage. I am now asking if anyone with the BOM is in the insurance business and can provide some assistance. The National SAR Color Guard is looking into insurance coverage for National Color Guard events as a "reenactment" organization. I will attempt to pursue that possibility as well, to obtain coverage for Florida SAR Color Guard events and related black powder salutes.

- Lineage section dates not properly formatted full known date should be 2 digit numeric day (i.e. 02), 3 character month (i.e. Sep) and 4 digit year (i.e. 2001). (i.e. 02 Sep 2001)
- Proof document missing, listed on application but not sent with the application.
- Unproven/unaccepted information used on application from a previous SAR, DAR and/or CAR
 application record copy.
- Service reference section left blank on application form.
- Chapter Name and State section left blank on application form.
- Lineage not correct for one or more generations.
- One or more required application signatures are missing on the application.

Recommended Application Submission Improvement Areas:

• The SAR embraces and has approved four membership application forms: MS/Word version; PDF version; SARApAid by Cox Software; and My Applications, the online application system. Links to the current updated version of each of these four forms is available from the SAR website by clicking on https://sar.org/application. Revised versions of the four forms have been acceptable since they were first approved by the Trustees in March 2017 but outdated versions of these forms, in particular the MS Word, the PDF, and the SARApAid forms, continue to be received at Headquarters. Now, the Trustees have set an effective date after which outdated versions of the forms cannot be used. At the 2018 NSSAR Fall Leadership Meeting, the Trustees approved October 31, 2018, as the effective date for use of only the current versions of these application forms. The new application forms have several important changes: removal of the spaces for listing of the applicant's children, a revision to the applicant's signed

certification, and addition of a space for signature of the Genealogist General. The current version date for each form type is:

- MS Word version: "adopted Feb 2017 SAR Application Form 2017" found on the bottom of the application form.
- PDF version: "Rev. Mar 2017" found on the bottom of the application form.
- o SARApAid by Cox Software: "Appaid Ver. 5.03... Feb 21 2018" found on the bottom of the application form.
- o My Applications (the online application system): This format does not have a revision date but any application printed after May 7, 2018 will automatically contain the required changes.

Only application forms with these, or more recent revision dates, will be accepted as of October 31, 2018. While leeway is certainly due those whose applications were in process at the time we reach the deadline, we need for this deadline to be respected and we request those who assist with application process – sponsors, genealogists, registrars, secretaries, and others – to assist our applicants in using the right application form and in avoiding the disappointment of having their form returned because of use of the wrong form. - There has been sufficient previous notification by GG and others which have been forwarded to all FLSSAR Chapter Registrars regarding the change in NSSAR policy regarding unproven information contained on submitted applications. Unproven information can no longer be submitted on applications. Likewise any applicable information contained on document submitted with an application must be annotated on the application in the appropriate places when applicable. Failure to comply with these requirements will result in a pended application.
- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
 printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
 take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for
 NSSAR requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two person of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

- New NSSAR Application/Genealogy Policy and Prep Manuals
 New versions of these manuals are available for download from the NSSAR website.
- NSDAR/NSCAR Record Copy Acceptance Criteria Change 2011-06, Applications from other lineage organizations. SAR will now accept an official record or chapter copy of a DAR or C.A.R. application

approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents. Applications approved before this date are acceptable for corresponding facts marked as individually-verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share: we do prefer copies of the documents themselves. Acceptance date for NSSAR record copies is 01 Jan 1074 and after.

As an active member of two local genealogical societies, a local historical society, and several other organizations that involve family research, I have contact with many people actively involved in family research. Many of the older ones are learning how to use computers, make use of DNA, etc., but complain that some of the people new to research look for fast, easy answers. Furthermore, they often do not see the difference between evidence and proof.

One area of research worries me - accessibility of public records. There appears to be efforts of some government agencies to make research more difficult. I can imagine the frustration of younger applicants trying to find birth records of ancestors less than 100 years old. People are living longer. I notice that some people show living persons as dead (false dates) on their family trees so they can publish information on-line. It seems

inconsistent that we worry about identity theft while posting all kinds of personal information on social media, like Facebook. Actually, Facebook is one of the few tools I can use to communicate with my younger relatives (They might use cell phones to text messages, but don't expect letters (exception - letters or cards in response to gifts! Of course, it is their parents that usually have to urge responses.)

Another tool I use to locate names of living relatives is to use "Fine-a-Grave" which often contains copies of obits which include surviving children, in-laws and grandchildren.

I have sometimes complained about some aspects of DNA as it applies to family research, but I must admit that it is becoming more useful and accurate as its data base increases and users understand its limitations. It has certainly helped me find many 4th cousins, including people I have known for years, but not realizing that we were related!

Like many of you, I have been to too many funerals lately! A common theme heard in funeral speeches is that the purpose is not only to honor and remember the dead, but to remember what that person's life has meant to us, so we, ourselves can have a better future. This can also apply to the aims and purposes of SAR - we can appreciate the sacrifices our patriot ancestors made so that we can enjoy the blessings of Freedom.

Statutory Committee Reports

Audit

Pursuant to Florida Society SAR Governing Documents, Bylaws, Article V, Section 2, Financial Review Committee (revision date: 10/16/2016), the FLSSAR Executive Committee (EXCOM) under the leadership of FLSSAR President Pat Niemann commissioned a Financial Review Committee led by the Honorable Bernard W. Wolff to conduct an analysis of the 2018-2019 financial activity of the Florida State organization. Each year an ad hoc committee is formed to review the record and insure all financial activity corresponds to the expectations of the membership.

The Financial Review Committee, acting as an independent agency within the FLSSAR, received explicit instructions that informed our activity in several areas of interest:

• Review the Treasurer's Annual Report.

- 1. A simplified, end of the year assets accounting indicates a sum of \$94,013.90 (checking account balance plus surplus) which is under 10 times the annual expenditures of \$139,018 which appears to obviate against any potential tax liability.
- 2. The Meeks Fund is currently up-to-date with all outstanding contributions being deposited per the Treasurer's end of year report (January, 2019).

Review the previous audit report.

- 1. The Documents Committee should review the Financial Review Committee charter [revision 10/16/2016, recommended in the 2016 Financial Review] and delete references to an Audit Committee.
 - **RESPONSE:** This action appears not to be completed. References were noted to indicate the word "Audit" can still be found, including in the instructions found within this set of instructions.
- 2. Authorized check signers for the Society need to be updated and remove those individuals who are deceased or otherwise no longer authorized by the Florida Society.
 - **RESPONSE:** The committee finds that the all previously authorized check signers for accounts held at Wells Fargo Bank have been deleted except for: Compatriot Richard Young, FLSSAR Treasurer; Compatriot Hall Riediger, FLSSAR Secretary; and, Compatriot Kevin Yarnell, all of whom are members of the FLSSAR Finance Committee.

Review the people and procedural controls for access to the funds before deposit.

- 1. Three people have access to the accounts at Wells Fargo Bank: the Registrar deposits monies collected for application fees; the Secretary deposits reinstatement fees and annual dues; the Treasurer deposits registration fees and all other checks mailed to the FLSSAR.
- 2. The Registrar and Secretary both send scanned copies of their deposit slips to the Treasurer which are matched to the bank statement.
- 3. The Treasurer makes any and all deposits to the Wells Fargo Money Market Account.

• Review all financial assets, the people authorized to access them, and documentation of transactions.

- 1. Wells Fargo checking account: the three abovementioned personnel are authorized signers to the account: Registrar; Secretary; and, Treasurer. The Treasurer has the only checkbook for the account.
- 2. Wells Fargo Money Market account: there are two signers for the account. No activity was reported in the end of year statement from Wells Fargo other than addition of some account interest. No checks were written, according to the December 31, 2018 statement recapitulation.
- 3. The Secretary and Treasurer are the only authorized users of the two credit card accounts from Wells Fargo Bank.
- 4. Treasurer card: as the statement dates falls on the 17th of the month, the January 2019 statement was analyzed which indicated an outstanding balance \$1, 014.99 (due in January 2019) with a credit limit of \$9,000.
- 5. Secretary card: An outstanding balance of \$14.99 was due in January, 2019.
- 6. A check balance of \$ 84,068.04 on the Wells Fargo Bank statement dated December 31, 2018 indicates a discrepancy with the cash assets stated in the checkbook of the Society for the same date. The difference of \$1365.10 was due to outstanding checks that had been cleared by the bank but not received for inclusion in order to balance the checkbook by the end of the year. The Registrar, Secretary, and the Treasurer are authorized depositors for the checking account with confirmation of deposits by the Treasurer. The Treasurer has the only checkbook and has signed all checks during fiscal year 2018. There are other authorized check signers. There are no authorized co-signers. There are no other checking accounts. There is one Money Market Account at Wells Fargo valued at \$57,358.72 on December 31, 2018.

A past two-cent addition error was addressed by the Treasurer and the appropriate entry made to balance the checkbook.

Review the people and procedural controls for making payments for asset disposal.

- 1. Monies are dispensed by the Treasurer when invoiced for budgeted committee or event related expenses, it is usually the Committee Chair or Event Leader sending an invoice or asking for reimbursement. If a bill is sent directly to the Treasurer, even though in the Budget, the Treasurer forwards the invoice to the committee or event leadership for his approval prior to sending a check.
- 2. The Treasurer relies on good sense with some bills and determines a threshold amount that, if exceeded, encourages him to seek approval (usually via email for an expeditious outlay) from the EXCOM (\$200-\$300) or possibly the BOM (\$500+) to gain approval of the expenditure. A solicitation for an off-budget payment from the BOM would be accompanied by an expected amendment to the budget. However, at times it is possible that a small, off-budget request would be honored if it appertained to FLSSAR interests (e.g., color guard). It is a judgment call for the Treasurer. A complete list of all budget line items and receipts/expenditures is provided on a year-to-date basis at each BOM for transparency.
- Audit the documentation filed to substantiate expenditures.

Ninety-seven checks were written in 2018 (numbers 1741-1838). Since this volume of checks written exceeded 55 checks, a random number equaling one-tenth were randomly selected to review. This is the suggested number for analysis directed by the supplied worksheet. A random number was generated by a tool found in the Excel spreadsheet. No discrepancies were reported by the committee.

• Write an Audit Summary letter to the president or chair (see below).

On February 2, 2019 the Financial Review Committee of the FLSSAR met with the Treasurer to perform the annual non-certified review of the Society's financial books and reports for the fiscal year January 1, 2018 through December 31, 2018. In response to the Financial Review Committee's request, we received from the Treasurer sufficient financial records and specifically requested documents to perform the annual noncertified financial review for fiscal year 2018.

We concluded that the financial statement as prepared by the Treasurer fairly represents the monetary transactions of the Society for the fiscal year ending December 31, 2018.

The cash balance of \$84,068.04 from the Wells Fargo Bank checking account accurately represents the assets of the Society on deposit. The current value of the Wells Fargo Bank money market account reflects an accurate amount of \$61,362.79 as of December 31, 2018.

Both credit cards carry only current balances which are discharged at the next billing cycle. Suggestions for Improvement:

- We suggest that a tickler file be established to assist as a reminder for the disbursement of funds to satisfy outstanding obligations.
- A reconciliation of the checking account should be made every two months to keep account values and activity clearly in mind.
- As in past recommendations, the word "audit" should be changed to "financial review" to accurately assess the
 function of the Committee, including the verbiage leading to and including the Summary Letter. In the case of
 the current Summary, the wording has been changed to indicate the change. This should be accomplished by
 tasking the Documents Committee to review the current Financial Review Committee charter (revision
 10/16/2016).

Included in the Appendix to these Proceedings is a summary of Cash Receipts and Cash Disbursements for the 2019 calendar year-to-date through April, listed by budget line item.

At April 30, the Florida SAR held approximately \$168,000 in its two accounts: Checking \$104,000 & Money Market \$64,000.

As we are only one-third of the way through 2019 and we have not yet presented all of the awards for the Youth Programs, it is difficult to say much about Cash Receipts & Disbursements other than there are not yet any significant surprises. Dues collections are complete and came in somewhat higher than expected; however, I will need to work with the

Secretary to identify and break out any *Patriot Magazine* annual subscriptions. At last report there were very few of these; accordingly, I do not expect to see a significant change in the Dues amount. Both Registrar Receipts (application fees) and Secretary Receipts (reinstatements) are running ahead of expected trend. These trends then result in higher than budgeted disbursements in NSSAR Dues, Reinstatement Dues and expenses of the Registrar and Secretary, which is mostly postage. Deposits were made to the Embassy Suites Hotel for future meetings. Deposits are not budgeted as they are eventually absorbed into BOM Expenses. The \$263 of Miscellaneous Costs are the last expenditures for the audio equipment approved by the BOM and budgeted in 2018. This BOM will be our first at the Embassy without the need for their audio equipment. Hall Riediger has secured storage space for the new audio equipment in the Orlando area. This is an unbudgeted expense for 2019; however, we should see a reduction in BOM Expenses as we discontinue use of rented equipment. Everything else spent to date seems to be in line with expectations.

The following proposed Bylaw and/or Charter changes have been received for review by the committee and will be reported at the Winter BOM as required by the FLSSAR Bylaws. Any additional proposed Bylaw or Charter changes should be delivered to the Documents Committee.

Spring 2019 BOM Action and Discussion Items:

Endowment Trust Fund (ETF)

The following discussions and ETF Reimbursements Proposal and Motion, together with Revised Instructions not reproduced here, were reported by the ETF Trustees and voted on at the Fall 2018 BOM. They were re-introduced and voted a second time at the Winter BOM in February, but without a second publication in the Florida Patriot 30 days prior to the BOM. They are being represented here, after the required publication and prior notice to the Compatriots, in order for the BOM Delegates to cast their vote.

Endowment Trust Fund Proposals:

- <u>C. 3</u>. Meal for Enhanced JROTC Program Winner, Rumbaugh, Knight, and Eagle Scout winners; two per recipient. (Limit \$20.00 per meal.)
- Proposed change Meals for Enhanced JROTC Program Winner, Rumbaugh, Knight, Americanism Poster contest and Eagle Scout winners (Limit \$40.00 per award)

Justification – these being youth awards, typically both parents would accompany their child, so that

means 3 meals. This would allow chapters with less expensive meals to get them covered. The Americanism Poster contest should be included.

- C. 4. Medals for Law Enforcement, Fire-Safety, Heroism, Emergency Medical Services, Bronze Good Citizenship awards and two meals per recipient. Other Medals purchased from NSSAR and presented to persons other than SAR members in recognition of their support of the Sons of the American Revolution, persons whose achievements are noteworthy in their school, community or state, or those currently serving or who have served in the Armed Forces of the United States, and two meals per recipient. (Limit \$20.00 per meal.)
- Proposed change Medals for Law Enforcement, Fire-Safety, Heroism, Emergency Medical Services,
 Bronze Good Citizenship awards. Other Medals purchased from NSSAR and presented to persons other than SAR members in recognition of their support of the Sons of the American Revolution, persons whose achievements are noteworthy in their school, community or state, or those currently serving or who have served in the Armed Forces of the United States. Meals limited to \$40.00 per recipient.

Justification – in the case of public service personnel a spouse and commanding officer would accompany the Recipient. This would allow chapters with less expensive meals to get them covered.

- <u>C. 5</u>. Chapters participating in the Habitat for Humanity outreach program may request reimbursement for the purchase of the porch/mailbox flag kits used in the program. Limit of \$20.00 per porch/mailbox flag kit with a maximum of 15 in a calendar year. Chapters must report the name of each recipient, and the date of each dedication.
 - Proposed change Chapters participating in the Habitat for Humanity outreach program may request reimbursement for the purchase of the porch/mailbox flag kits used in the program. Limit of \$300.00 per year.
 - Justification Large chapters in large cities may have more than 15 homes in a year. If they purchase the cheaper kits they can accommodate more homes and the chapters with fewer homes can purchase a higher quality flag kit.
- C. 13. Engraving expenses not to exceed \$5.00 per award.

Proposed change - Engraving expenses – not to exceed \$10.00 per award.

Justification – SAR charges \$10 to engrave a medal. A local jeweler I use charges \$10.

Proposed additions:

- C. 16. Support to Boy Scout Councils (Limit \$100)
- **C. 17.** Support to JROTC units (Limit \$100)

Propose that these changes become effective Nov. 1, the beginning of the new claim year

2023 Florida Congress Task Force

- The 2023 Florida Congress Task Force was established by President Pat Niemann at the 2018 Fall BOM, and a Proposal was successfully submitted and presented at the 2019 SAR Spring Leadership Conference at the Brown Hotel in Louisville Kentucky. Florida and Orlando were selected by the SAR Trustees on 2 March 2019.
- The 2023 Florida Congress Task Force will meet formally at the 2019 FLSSAR Spring BOM. Now that Florida has been selected, the Task Force has asked for full Committee status. If granted, a Committee Charter is expected to be developed, and notice of same published, in time for approval of full Committee status at the 2019 FLSSAR Fall BOM in October.

Membership Assignment: A Chairman and additional Members, normally four, as the President, Florida Society may appoint and whose terms shall be concurrent with that of the appointing officer.

With the popularity of TV Genealogy programs like "Finding Your Roots" and commercials for Ancestra.com, the general public is becoming more interested in learning about their family history, especially if they think that DNA technology will make it easier. I have four points to make a:

- 1. When family or friends mention DNA, Ancestry.com, etc. use the opportunity to talk about your membership in the SAR or your mate's participation in the DAR.Share with them your good experiences in the organization, Let them know that searching for ancestors can be FUN!
- 2. Urge your people to share their interest and enthusiasm with their children. Urge them to involve the kids in the research. Functions:

- 1. Through the chapters, to encourage Americanism which is devotion and loyalty to the United States, its traditions, its customs and its institutions.
- 2. To encourage chapter participation in Allegiance Sunday programs which are held on the Sunday of the 4th of July, or the Sunday immediately prior to the 4th at which allegiance to the United States is reaffirmed.
- 3. To encourage participation by chapters at the naturalization of new citizens and develop programs which delineate the duties, rights and privileges of all citizens.
- 4. To develop programs of Patriotic Educational Significance for presentation before school, citizen, fraternal, and civic groups. Programs may be of historical documents, or biographical sketches of individuals or groups who had impact on the establishment and development of the United States.
- 5. To administer the Flag Program for the Florida Society to include competition for the rear Admiral William R. Furlong Award to the State Society with the best Flag Program, award and present the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourage FLSSAR chapters to

participate in Flag Day, June 14, ceremonies, and promote respect and honor to the Flag of the United States. Encourage chapters to present the NSSAR Flag Retirement Certificate (NEW) to individuals and activities in the name of the FLSSAR.

- The Admiral William R. Furlong Memorial Award is presented to societies with at least 50% of chapters presenting at least one Flag Certificate. In 2018, 12 of Florida's 34 chapters presented 28 certificates. They include Aaron Snowden, Caloosa, Clearwater, Charlotte, Flagler, Gainesville, Highlands, Jacksonville, Palm Beach, Saramana, Withlacoochee, and William Dunaway. We were very close and several chapters had multiple presentations during the year. Chapters have also started making presentations for 2019. We will do better in 2019.
- With Flag Day approaching, time is ripe to look to local churches, schools, businesses, veteran's organizations, neighborhood associations, civic groups and other candidates. Presentations of certificates can be simple or elaborate. Usually they take only a few minutes with a member introducing himself, talking briefly on the importance of or history of the American flag, explaining the award, and presenting it to the group. Certificates can be presented in an SAR folder, in a frame, or mounted to a plaque. If the certificate is mounted or framed, it is more likely to be put on display rather than stuffed in a drawer. Flag Certificates and the new Flag Retirement Certificates are available from the SAR store for only \$4.
- Allegiance Sunday is held on the Sunday closest to July 4th. Compatriots are encouraged to contact the head of their congregation or church to see what activities are planned to recognize Independence Day. These observances are opportunities to offer the services of the color guard or to have a member lead worshipers in the pledge of Allegiance. A Flag Certificate could also be presented if appropriate.

Public Service and Heroism

- The **Public Service and Heroism Committee** (PS&H) recognizes and honors citizens and individuals in our public service sectors of Law Enforcement, Fire Safety and Emergency Medical Services for their contributions to the community and for Heroic Acts with a commendation and medal. States, chapters and commendation recipients are recognized in a booklet published and distributed at the National Congress each July.
- The Law Enforcement Commendation Medal is presented to those who have served with distinction and devotion in the field of law enforcement. The medal is intended to recognize exceptional service or accomplishment in the field of law enforcement. Eligibility is not limited to peace officers but extends to the entire range of persons who make and enforce the law. This includes peace officers, attorneys, judges, prosecutors and legislators who have performed an exceptional act or service beyond that normally expected. The recipients are usually recommended by their supervisors or peers for their accomplishments. The award may be presented posthumously. The medal may be presented to an individual only once. No Oak Leaf Clusters or ribbon attachments are permitted.
- The **Fire Safety Commendation Medal** is presented to an individual for accomplishments and or outstanding contributions in an area of fire safety and service. The award is not limited to firefighters. It may be presented to recognize a variety of fire safety and services that have evolved into a highly technical and skilled profession with constant study, development and involvement by numerous dedicated citizens with a single goal, which is protecting human life and property by preventing injuries or casualties due to fire and chemicals. The medal may be presented posthumously. The medal may be presented to an individual only once. Oak Leaf Clusters or other ribbon attachments are not authorized.
- The **Emergency Medical Services Commendation Medal** is presented to an individual for accomplishments and/or outstanding contributions in the area of emergency medical services. The award is intended for paramedics, certified Emergency Medical Technicians, and others in the emergency medical fields that have performed an act or service beyond which is normally expected. The medal may be presented posthumously, The medal may be presented to an individual only once, and no Oak Leaf Clusters or ribbon attachments are permitted.
- A **Heroism Commendation Medal** recognizes outstanding bravery and self-sacrifice in the face of imminent danger—i.e., acts which involve great personal courage and risk to the recipient. It is intended primarily for acts by civilians, not in uniform, but does **not** exclude police, firemen, EMS SAR members. It is not intended to recognize acts that would have been covered in the performance of one's normal duty, nor by medals for valor by the armed forces. Animals are not eligible for recognition. The medal may also be

presented posthumously. An individual may receive this medal multiple times. Presentation and the wearing of Oak Leaf Clusters shall follow NSSAR policy.

The **SAR Life Saving Medal** is presented to those individuals who have acted to save a human life without necessarily placing their own life or themselves in imminent danger. The medal is intended primarily for acts by civilians not in uniform, however, police officers, fire fighters, emergency medical personal, lifeguards, and SAR Compatriots are not excluded from receiving this award.

The medal is not intended to recognize acts that would otherwise qualify for military or another organization's valor medals and, in all cases, the fact that the actions of the rescuer actually saved the life of the victim must be validated by EMS or medical personnel. Lifesaving examples include, but are not limited to, the following:

- 1. Performing the Heimlich maneuver or other first aid to prevent a person from choking;
- 2. Saving a person from drowning by bringing the person to safety;
- 3. Performing cardiopulmonary resuscitation (CPR) or rescue breathing until the person breathes normally; or
- 4. Performing CPR or applying an automated external defibrillator (AED) on an out-of-hospital cardiac arrest before EMS arrival.

The medal is intended to recognize the actions of any person: (1) who was directly responsible for the saving of a human life or (2) who prolonged a human life to the extent that the victim was still alive upon transfer to the care of medical authorities even though the victim might expire at a later time. Only one award will be awarded for each incident regardless of the number of victims involved. Nominations will not be considered after a lapse of 24 months of the incident. The medal may also be presented posthumously.

Veterans Recognition Committee continues to work with Chapters to expand the membership of the FLSSAR Veterans Battalion with Compatriots who served honorably in the armed forces. Chapter Presidents are contacted on a Quarterly basis and encouraged to promote Veterans Battalion recognition within each chapter.

Veterans Battalion Roster has been updated on the FLSSAR web site listing of all 596 Veterans Battalion members.

The committee chairman is processing Veterans Battalion requests within 24 hours of receipt of VB application form with proof of honorable service DD-214, and mailing the VB Certificate within 48 hours to the Chapter for presentation.

Chapter Presidents are encouraged to present the Veterans Battalion Certificate along with the authorized Military Service or War Service medal to each approved Compatriot at a chapter meeting. The chapter is encouraged, but not required, to purchase the medal for each compatriot directly from SAR.org.

Chapter Presidents are reminded that the SAR War Service Medal may only be authorized for Compatriot veterans with proof of service directly within a DOD designated "combat area" as noted on their DD-214. Non-combat related service qualifies for the Military Service Medal.

The committee continues to work with Chapter Presidents and the NSSAR Veterans committee to help FLSSAR Veteran Battalion members apply for the NSSAR Veterans Corp recognition.

Endowment Trust

In 2018, 24 Chapters were reimbursed \$15,568.99, up from 16 for \$8,956.21 in 2017. This was a welcome increase in the participation of the ETF by the Chapters, but put a strain on the cash flow. Accordingly, in accordance with the Trust document and the policies and procedures of the ETF Distribution Committee, the distribution percentage was increased to 5% in order to provide for the increased demand. This percentage has been continued for 2019 to accommodate the increased usage of the ETF by the Chapters.

The fund is invested conservatively by Regions Bank in accordance with the Investment Policy Statement promulgated by the Trustees. Happily, the fair market value is higher from a year ago, after providing for distributions and administrative expenses.

Operating Budget Trust

For the year 2019, \$3,000 was provided for in the FLSSAR Operating Budget as the approximate contribution generated by dues. Additionally, as usual, a similar amount was planned to be distributed by the Trust back to the FLSSAR Operating Budget account to help defray expenses. However, uncertainties around the bid for hosting a future Annual Congress have held up the distribution pursuant to conversations with the Treasurer. It is possible that the above contribution representing the usual 3% "unitrust amount" could be elevated 1 or 2% for a proposed Congress Fund. The OBT is invested conservatively by Regions Bank in accordance with the Investment Policy Statement promulgated by the Trustees. Happily, the fair market value is higher from a year ago, after providing for distributions and administrative expenses.
