


- Included in these minutes are general topics of discussion and proposed Motions and the action(s) taken on those motions.
- Vote to accept previous minutes. After corrections accepted, Approved. NO Motion made.
- ETF Changes, from documents: Motion Lee Popham, no second needed, C-3 Meal for enhanced JROTC Program winner, Rumbaugh, Knight and Eagle Scout winners: two per recipient (Limit \$20.00 per meal). Change to meals for Enhanced JROTC Program Winner, Rumbaugh, Knight, and Americanism Poster. Motion: Passed.
- Finance committee: Investigate and implement an electronic payment system in the best interest of the Florida Society, Motion Lee Popham, and Second Richard Young. Motion: Passed
- Motion to Adjourn, Passed Unanimous

#### Annual Meeting

- Discussion on difficulty of staging Battle of Pensacola due to controversy with local agencies.
- Motion to elect slate of Officers as read, Motion Pat Niemann, second Carl Hoffmann. Passed unanimously
- Motion Lee Popham, second Dick Young. The Nominating Committee for 2020 is Pat Niemann,
   J Michael Tomme, Steven Fields, James Gaskins and David Bussone. Passed unanimously.
- Motion made to nominate as the Florida Candidates Pat Niemann as Trustee and Robert McGuire as Alt Trustee. Passed unanimous
- Adjourn, Passed Unanimous

## **National and State Officer Reports**

#### **National Trustee**

#### **Robert McGuire:**

The affairs of the SAR are managed by its national trustees (one from each of the state-level and international societies), fifteen regional vice presidents, and ten national (general) officers. Each year, these men meet several times at the national SAR Headquarters in Louisville, Kentucky, to conduct business. Delegates from all state-level societies also meet annually for a multi-day session in a different city for an Annual SAR Congress. Over sixty committees made up of scores of SAR members also meet regularly to discuss, plan, and act to achieve the SAR's objectives.

At the May 2018 FLSSAR Annual Meeting, Robert Folk was nominated to serve as Florida Trustee and I was nominated to serve as Alternate Florida Trustee. At the July 18, 2018 National Congress meeting in Houston we were both elected to those respective positions. As Alternate Trustee, it is my responsibility to act as Trustee in the event that the regular Trustee is absent at a meeting. Because Trustee Folk was absent at the 2019 Congress in Costa Mesa CA, I served in his place representing the Florida Society, SAR.

On Sunday, 7 July 2019 a meeting of the Trustees was called to order. After the usual rituals and introductions, the agenda followed with Unfinished Business. PG Tomme who is leading the Mission Data Base and Mission Website Projects reported good progress on both with implementation hoped for early in the next calendar year. However, he cautioned that there will be no roll-out until it is confirmed that everything works as intended and "we get it right". He was followed by reports from Budget Director Lee Popham and Director of Finance Mary Butts. A detailed NSSAR Budget Workbook Package for FY 2019 was published and distributed to attendees and is available on Sharefile or on request from me. Form 990-N was filed on time with the IRS and public versions are available on the SAR (and other) websites.

- An important function of the Trustees is to consider and act upon proposed changes to the Constitution and Bylaws of the NSSAR. There were several such changes voted upon. One dealt with the definitions of membership categories. This added two additional categories (Life & Emeritus) that are found in the Bylaws but not the Constitution (passed). Another proposal had to do with language amending Article 33 Discipline, Procedure, and Due Process which involved disagreements between the Executive Committee and the Bylaws Committee. After much discussion (and an evening joint meeting of the committees) agreement was reached involving little change to the Bylaw. Finally, proposals by the Indiana Society which would extend the term of office for most General Officers from one year to two, and the composition of the Nominating Committee were defeated with little controversy. Other changes dealt with involved minor language changes (memorial membership, audit, museum board, and reinstatement of life members) were all passed without opposition.
- The Trustee meeting was followed by a Color Guard review by the PG and a Memorial Service with past Chaplain General Rev. Dr. Randy Moody and present State Chaplain Dwight Elam participating. A total of 31 Florida Compatriots were memorialized.
- Monday July 8 2019 included the opening ceremonies for the 129th Congress which included the Color Guard posting of Colors and greetings from numerous dignitaries among whom was DAR President General Denise Doring Van Buren who also and presented the program at the Ladies Auxiliary luncheon.
- Monday evening included the annual Minute Man and Awards & Recognition banquet. Once again, the Florida Society was recognized with numerous awards and streamers.
- On Tuesday July 9 2019 the day began with District breakfasts with my attendance at the South Atlantic District breakfast. Candidates for General Officer positions visited and made campaign speeches. At the conclusion, Mr. Allen Greenly of Georgia was installed as the new Vice President General for the District, replacing Daniel Woodruff. In the afternoon, election of General Offices was conducted. Only one position was contested Registrar General where Douglas Collins ran against John Thornhill for the position. Collins was elected. Other notable results are John T. Manning of Massachusetts succeeding PG Warren Alter as President General and Davis Wright Manning as Secretary General.
- This was followed by a general session of Congress and that evening, the President General's Banquet. Part of the program included the change of command of the SAR Color Guard with James Fosdyck relieving outgoing commander Mark Anthony.
- On Wednesday, July 10 2019 the final session of Congress was held. Following that, there was a Trustees meeting which included installation and swearing of Trustees and Alternate Trustees for the 2019-2020 term. Florida nominees COL Pat Niemann (Trustee) and LTC Robert McGuire (Alternate Trustee) were sworn at that time. The next Trustee meeting will be at Leadership in Louisville September 19-22, 2019. I anticipate that both Pat and I will attend.

#### Pat Niemann:

- On Saturday, September 21, 2019 a meeting of the Trustees was called to order by President General Jack Manning. After the usual rituals and introductions, the agenda followed with Secretary General Davis Wright announcing motions that were approved at the ExCom. An Internal Audit Committee was created and the members are James Maples, AL; James Jones, TX; Thomas Jackson, TX; Compatriot Stewart, MD; Kenneth Collins, GA; Compatriot Andes, PA; Harry Roberts, DE; Bruce Pickette, Ex-Officio.
- SG Davis also stated that a request to approve the Color Guard Manual was pending approval awaiting input from the Insurance and Risk Committee.
- SG Davis presented five motions to the Trustees for a vote:
  - 1. A motion to amend the Solid Light Project, Phase 2, step 2 contract that is has a budget of \$550,000. The amendment was to add a retail store which would be part of the SAR Education Center and Museum. There is no cost involved as the store can be added with the current budget. The motion was approved.
  - 2. A motion to transfer \$5,000 from the Special Purpose Stamp Fund to the Special Purpose Fund 250<sup>th</sup> Anniversary Fund. The motion was approved.
  - 3. A motion to transfer and expend \$10,000 from the Kings College budget to purchase two iPads and upgrades of equipment for the IT staff. The funds are not needed for Kings College for the remainder of the year. The motion was approved.
  - 4. A motion to allocate \$38.5K of the Alexander Hamilton Fund to upgrade/rework the on-line data system. There are current issues with some the code that needs to be corrected. The motion was approved.
  - 5. The motion to approve the NSSAR budget totaling \$327,200 was approved.
- Paul Callahan reminded the group that the hotel for the 2020 Congress will be held July 11-16<sup>th</sup> at the Marriott Richmond Downtown, 500 E. Broad Street. The remaining rooms only have double beds there are no king beds available as they have all been reserved. He also stated that two tours will be available on July

11th that will be limited to the first 150 people as there are only two buses available. One tour is the American Revolution Museum at Yorktown and the other to visit three VA plantations.

The Congress Planning Committee made a motion that the 2024 Congress be awarded to the PA Society with the location undecided although it will most likely be Philadelphia The motion passed.

The Historic Sites Committee announced that they approved three new national sites. Those sites are the Battle of Eutaw Springs, SC; Battle of Princeton, NJ; and Battle of Red Bank, NJ.

A national dues billing system is being tested by the CA, DE, MO, and Spain Societies.

I started the year by saying LET'S GROW TOGETHER. If we do nothing more than file applications for our own children, grandchildren, siblings, uncles and nephews, I believe we can become the largest Society in SAR – after all, we are already the BEST! Bring your family history materials with you to the Fall BOM, and drop in on the Patriot Research System (PRS) Workshop – our volunteers and Chapter Registrars in attendance will drop whatever else they are doing, and help you get your Membership, Supplemental, and Memorial Applications completed and filed. Each BOM is open to everybody, so bring your prospective members too!

- 1. Since the last Board of Management, the Member @ Large Officer sent the 3rd email communications to all Chapter Presidents asking for their feedback and input. The overall response to the emails was disappointing with less than 10 responding. Feedback on questions:
  - a. Chapter Presidents provided feedback on their most pressing chapter issues and motivation suggestions to increase BOM attendance.
    - **i.** Most pressing chapter issue included: meeting attendance, recruiting, retention, and lack of FLSSAR direction, chapter management support and general educational support.
    - ii. How to increase BOM Attendance: Better Pre-Event Promotion, Schedule Interesting Break Out Sessions, Guest Speakers, Less parliamentary proceedings/issues, more civic/community service discussions.
    - **iii.** Biggest issue, however, was the overall expense averaging \$400+ including hotel/travel. Some suggestions: Consider Regional BOMs, i.e. North, Central, South, that could allow more members to attend.
  - b. Chris Washler President Pensacola Chapter proposed an idea for a statewide "Chapter Presidents Forum" via a closed Facebook page or similar social media platform for Chapter Presidents, RVPs and Officers to share ideas on new member recruitment, retention, meeting management ideas, BOM topics, involvement with other chapters and the DAR, and provide feedback to FLSSAR Officers. - Lineage section locations do not conform to required format which is "City/County/State" such as commas used instead of "/" or "/" not used even if city and/or county not known.
- Lineage section dates not properly formatted full known date should be 2 digit numeric day (i.e. 02), 3 character month (i.e. Sep) and 4 digit year (i.e. 2001). (i.e. 02 Sep 2001)
- Proof document missing, listed on application but not sent with the application.
- Unproven/unaccepted information used on application from a previous SAR, DAR and/or CAR application record copy.
- Service reference section left blank on application form.
- Chapter Name and State section left blank on application form.
- Lineage incorrect for one or more generations.
- One or more required application signatures are missing on the application.

#### **Recommended Application Submission Improvement Areas:**

- The SAR embraces and has approved four membership application forms: MS/Word version; PDF version; SARApAid by Cox Software; and My Applications, the online application system. Links to the current updated version of each of these four forms is available from the SAR website by clicking on https://sar.org/application. Revised versions of the four forms have been acceptable since they were first approved by the Trustees in March 2017 but outdated versions of these forms, in particular the MS Word, the PDF, and the SARApAid forms, continue to be received at Headquarters. Now, the Trustees have set an effective date after which outdated versions of the forms cannot be used. At the 2018 NSSAR Fall Leadership Meeting, the Trustees approved October 31, 2018, as the effective date for use of only the current versions of these application forms. The new application forms have several important changes: removal of the spaces for listing of the applicant's children, a revision to the applicant's signed certification, and addition of a space for signature of the Genealogist General. The current version date for each form type is:
  - o MS Word version: "adopted Feb 2017 SAR Application Form 2017" found on the bottom of the application form.
  - o PDF version: "Rev. Mar 2017" found on the bottom of the application form.
  - SARApAid by Cox Software: "Appaid Ver. 5.03... Feb 21 2018" found on the bottom of the application form.
  - o My Applications (the online application system): This format does not have a revision date but any application printed after May 7, 2018 will automatically contain the required changes.

Only application forms with these, or more recent revision dates, will be accepted as of October 31, 2018. While leeway is certainly due those whose applications were in process at the time we reach the deadline, we need for this deadline to be respected and we request those who assist with application process – sponsors, genealogists, registrars, secretaries, and others – to assist our applicants in using the right application form and in avoiding the disappointment of having their form returned because of use of the wrong form. There has been sufficient previous notification by GG and others which have been forwarded to all
FLSSAR Chapter Registrars regarding the change in NSSAR policy regarding unproven information
contained on submitted applications. Unproven information can no longer be submitted on applications.
Likewise any applicable information contained on document submitted with an application must be
annotated on the application in the appropriate places when applicable. Failure to comply with these
requirements will result in a pended application.

- NSSAR is identifying and will reject photocopied applications being received on SAR archival paper. A
  printer does a better job of injecting ink into paper if the copy prints from a computer command. If you
  take a printed application and simply photocopy it onto SAR watermarked paper it is insufficient for
  NSSAR requirements.
- Enclose 1 application copy on SAR watermarked archive paper and 1 application on plain paper for all applications submitted.
- Ensure all required signatures and dates are present as required for type of applications being submitted.
- Do not submit NSDAR web site printouts from the "Descendants Database Search" or NSDAR "Patriot Index" information. This information is not acceptable for either lineage or service and NSSAR does not want this unacceptable information included with any application.
- Ensure <u>ALL</u> applicable information contained on all submitted proof documents is recorded in the applicable sections of the application. Do not list references that are not being submitted and list all documents that have been submitted.
- Ensure all known spouse information is included when known for each generation even when the spouse is not in direct lineal descent. This will prevent applications from being pended when two person of the same name are living in a given area and this information would assist in identification of the correct person used on the application.
- Only one set of proof documents are required to be submitted with each application. This also applies when submitting more than one application under the family plan criteria. One set of proofs only for the common documents used by all the applications in the group. His does not apply to multiple supplemental applications submitted at the same time. Supplemental applications are always considered separately and require complete sets of documentation.
- Use a red pencil to underline applicable data on all proof documents and DO NOT USE any type of highlighter.
- Copy of entire legible original census page must be submitted when using a census as a proof document. Ancestry.com census transcription pages cannot be used in lieu of the original census page, but may be used in addition to the original page.
- Never use nick names on an application unless there is a required proof document has been submitted that validates the nickname.

#### New NSSAR Application/Genealogy Policy and Prep Manuals

New versions of these manuals are available for download from the NSSAR website.

- NSDAR/NSCAR Record Copy Acceptance Criteria Change 2011-06, Applications from other lineage organizations. SAR will now accept an official record or chapter copy of a DAR or C.A.R. application approved after 1 January 1985 as evidence of lineage and related fact except where DAR, C.A.R. or SAR has determined that the facts have been determined to be incorrect. In other words, center checks on applications approved after 1 January 1985 no longer prevent a DAR application from being accepted in lieu of other documents. Applications approved before this date are acceptable for corresponding facts marked as individually-verified on DAR and C.A.R. applications. The subcommittee acknowledged that there were arguments on both sides of the issue and what it proposed was a middle ground that it deemed in the overall interest of the organization. No review process is perfect, but the overall DAR review process is an excellent one that includes a number of checks and balances. The old policy was clearly confusing to many applicants, chapter registrars, and state registrars, and the genealogy staff was spending a great deal of time requesting further information relating to DAR applications. Compatriot Peterman made a point in discussion I think all of us share: we do prefer copies of the documents themselves. Acceptance date for NSSAR record copies is 01 Jan 1074 and after.

At the end of the BOM Book, you should find a summary of cash receipts and cash disbursements for 2019 through September 30. These schedules also include a Proposed Budget for 2020. As shown on those summaries, at September 30, we had a 2019 year-to-date cash surplus of \$13,681. There are several factors that contribute to this large surplus so late in the year:

- > There are no Magazine subscription revenue collections
- > The annual donation from the Operating Budget Trust Fund has not yet been received
- > The current President and SVP have not yet asked for reimbursement of any personal expenses spent on Florida SAR business
- > The Medals & Awards Committee has spent substantially less than budgeted
- > There has been no spending on New Chapter Development
- We have not acquired Liability Insurance
- We have not made the budgeted contribution to the Endowment Trust Fund
- ➤ We have not made the budgeted transfer to the Meeks Fund

Some of these items are expected to be discussed as possible fund-raising sources for the 2023 Congress. To divert these budget line items will require a 2019 Budget amendment and must be approved by the BOM.

The Proposed 2020 Budget shows a balanced budget; however, this was attained only by increasing budgeted dues collections by \$5,000 and allowing for \$1,000 in Patriot Magazine subscription collections. These revenue items may not be realistic. You will note that the cost of printing and delivering the Patriot Magazine was reduced by nearly 50%, as it is expected that we will print and mail a hard copy of the magazine only to those compatriots who pay the \$12 annual subscription fee, if any. Other items that may come up for discussion will be the expected requests for additional financial support for C.A.R., Outreach Education, Youth Contest Awards, 2023 Congress, 2020 Battle of Pensacola Commemoration (yes- there will be one) as well as the possibility that \$2500 will not buy the liability insurance we want and the inevitable requests for other donations here and there. These items would need to be discussed at the BOM as part of the 2020 Budget approval process.

As always, if there is ever anything I can do to assist any chapter with its chapter finances or required filings, please feel free to call on me at any time.

We have received information regarding several qualifying hotel facilities in the Orlando area, and site visits for 6 or 7 of these hotel and convention facilities are expected to take place during the last week of October 2019.

All proposals submitted by the Hotels are either for the 13-20 July 2023 or 20-27 July 2023. A Church visit is also expected to take place, in order to select an appropriate forum for the annual Memorial Service that takes place – in Colonial uniform and dress – at each Congress.

The full text of our successful Proposal appears below. Several preferences were stated, but are still subject to the approvals of NSSAR and Florida SAR:

Subject: National Congress Hosting Proposal – Florida Society SAR

- The 2,500 Compatriots of the Florida Society request the honor of hosting the 133<sup>rd</sup> National Congress of the Sons of the American Revolution in 2023. The Florida Society last hosted the National Congress in 1995 in Orlando. After more than 25 years, we, of the Florida Society believe it is time to invite the National Society to return to Florida.
- We submitted a bid on the 131<sup>st</sup> National Congress in Jacksonville two years ago, and we congratulate the Washington Society for their successful bid. We again submitted a bid on the 132<sup>nd</sup> National Congress in Jacksonville last year, and we congratulate the Georgia Society for their successful bid. We are asking again, but we believe Jacksonville is too close to Savannah where the 2022 Congress will be held, so we are moving our proposed site to Orlando.
- Based on the Orlando area site and hotel surveys conducted in preparation for this 2019 request, we recommend that the host hotel be the Embassy Suites by Hilton Lake Buena Vista South, where our own Florida SAR meetings have been held for the last four years.
- From the establishment of the first European settlements in the United States, to the present Space Age, Florida (Land of Flowers) has played an integral role in the history of our nation. Our State's role in our nation's history and Florida's part in that history is our proposed theme of the 133<sup>rd</sup> National Congress of the National Society Sons of the American Revolution.

Year: 2023

Proposed Host City: Orlando, Florida

Proposed Dates of Congress: 8 - 12 July 2023

Last Year and Location of Hosting: 1995 in Orlando, Florida

## **Special Occasion:** 250<sup>th</sup> Anniversary of British Conquering East and West Florida, causing only 13 Colonies to Participate in the American Revolution (instead of 14)

Historical Significance of Florida and the American Revolution:

- Florida is the geographical location of three documented Revolutionary War battles; The Battle of Thomas Creek in Jacksonville, The Battle of Pensacola, and The Last Naval Battle of the American Revolution off the coast of Cape Canaveral.
- During the American Revolution, Florida was actually two separate British Colonies: East Florida had its capital city at St. Augustine; and West Florida's capital city was located at Pensacola.
- The fort at St. Augustine, originally built by the Spanish Conquistadors in 1565, served as a British stronghold, and the key location in the supply of goods to England, and throughout the 52 British Colonies in the New World. St. Augustine's garrison was also a war prison for captured American Army and Navy prisoners.
- The Spanish Governor of Louisiana, Bernardo de Galvez, recruited and led a successful Spanish militia attack on the British garrison in Pensacola, thus removing a British stronghold in West Florida. General George Washington authorized at least two attempts to attack St. Augustine during the war, both of which ended in failure

## Congress Theme: "FLORIDA: THE 14TH COLONY – FROM THE OLDEST ESTABLISHED CITY TO THE LAST NAVAL BATTLE OF THE REVOLUTION, HISTORY ABOUNDS"

Hotel Survey:

- Helms Briscoe conducted a hotel survey of our first-choice host city ORLANDO. Attached in the enclosed supporting documentation is the survey for our preferred hotel, the Embassy Suites by Hilton Orlando Lake Buena Vista South, located at 4955 Kyngs Heath Road in Kissimmee, Florida, a suburb of Orlando in close proximity to the Orlando International Airport, Disney World, Florida's Ronald Reagan Turnpike leading to I-75, and the I-4 Interstate Highway.
- The Florida SAR is very familiar with the rooms, amenities, and staff of this facility, as this hotel has been the home of all Florida Society Board of Managers (BOM) and Annual Meetings for the past four years, and we have contracted for at least two more years through 2020. The hotel has been hosting a free cocktail hour every evening during our meetings, and the room rates include free buffet cooked breakfasts with complimentary omelet and cooking stations, every morning. The hotel rooms are all Suites, and can easily accommodate two couples, if attendees wish to reduce the cost of their Congress attendance. It meets the minimum needs of a hosting facility for a National Congress.

Accessibility:

Orlando is completely accessible by car, train, and air. The city is served by major interstate highways, including: From the North and South by I-95, I-75, I-4, and the Florida (Ronald Reagan) Turnpike. These routes are intersected from the East and West by I-10, I-20, I-26, and I-40. The Orlando area is one of the most popular summer recreation destinations in the United States, and the site wil be easily accessible by car for a large majority of our Compatriots living in the Atlantic States, the Midwest States, and the Gulf Coast States. The East Coast Auto-Train terminates in Sanford, Florida, approximately 20 miles from the hotel site. The area is also served by Amtrak on its eastern seaboard and western routes, and there are several RV parks in the immediate area – including Fort Wilderness at Walt Disney World.

The Orlando International Airport is one of the largest airport facilities in the Eastern United States, with enough daily seats to fill Disney World, Universal Studios, and a hundred other vacation destination facilities on a daily basis – and there will probably be enough capacity to accommodate our SAR Compatriots as well.

#### Memorial Service Venues:

There are several church facilities in close proximity to the proposed host hotel site. See the attached map and church listing in this proposal package.

#### Ladies Luncheon Sites:

The Embassy Suites by Hilton Orlando Lake Buena Vista South is a convention/tourist destination hotel and has numerous sites suitable for hosting a Lady's Luncheon.

#### Potential Offsite Excursions and Events:

Aside from the famous attractions in the Orlando area – Walt Disney World, Universal Studios, Sea World, etc., we are in the process of investigating the following:

- Field Trip to Cape Canaveral and the Kennedy Space Center
- Daytona Speedway NASCAR race tickets on Saturday, 8 July 2023 Color Guard Opportunity on National Television?
- Tampa Bay Rays baseball home game Color Guard Opportunity?
- Quail Creek Plantation, Okeechobee FL 14-station Sporting Clays Shotgun Event
- River Ranch Estates, Orlando Area Saturday Night Rodeo and afternoon airboat rides
- St. Augustine field trip and history tour
- Tour of The Villages, the fastest-growing retirement community in the United States

#### Significant Reason for Choosing Florida to Host the National Congress:

Florida, in general, is a premiere tourist destination with its world class beaches, Walt Disney World, Busch Gardens, etc. Many of our Compatriots have been looking for a reason to travel to Central Florida for a vacation, and maybe even to investigate a move to Florida for retirement.

The Florida Society is the second largest NSSAR Society. Attendance at a National Congress that is close to home should attract many new "First-Timers," who will enjoy themselves so much, that they might choose to become regular Congress attendees in future years.

Florida is rich in history. The first established city in America was founded in St. Augustine, approximately a 1.5-hour bus ride from the host hotel. St. Augustine was founded in 1565 by the Spanish conquistadors. Many of the old city's historical structures and the Castillo de San Marcos are open for touring.

The Orlando site is one hour away from Cape Canaveral; less than one hour from the famous Daytona Speedway, and approximately one hour away from Tropicana Stadium, home of the Tampa Bay Rays professional baseball team. Excursions to these facilities should not be out of the question.

#### Fundraising and Funding of Hosting a National Congress:

The Florida Society currently has cash reserves to totally fund its responsibilities of hosting a Congress; however, we don't intend to spend ANY of those reserves, and they will only be used as a backstop for funding. There are currently plans in the works to establish the following funding sources:

- Design and sell 2023 Orlando Congress Medals;
- Design and sell a unique 2023 Orlando Congress commemorative coin;
- Design and sell unique Florida Society Medals, which will be available to Florida SAR meeting First-Timers and purchasers after the 2023 Congress;
- Solicitation of voluntary donations from Compatriots
- Grant applications from the Kissimmee and Orlando convention bureaus;
- "Project Sales" and donations of In-Kind goods and services from convention vendors
- Raffles and Drawings for significant eye-catching prizes (e.g., a motorcycle, powerboat, or cruise); a handmade authentic Colonial Uniform or other appropriate garments; a five-night stay at the host hotel; and, an appropriate replica firearm.
- Anything else we can think of between now and 2023

#### Summary:

The Florida Society SAR looks forward to hosting the 2023 National Congress of the Sons of the American Revolution. We have the enthusiastic support of our Compatriots, and we believe that Orlando and its surrounding cities and activities provide a compelling reason for holding a "family vacation Congress" in the Sunshine State. These are two extremely important aspects of a successful Congress. Therefore, we respectfully ask that you award the Florida SAR the opportunity to host the 2023 NSSAR National Congress.

We look forward to our seminars, discussions, workshops, and fellowship at the Fall 2019 BOM in Orlando.

The NSSAR DAR Liaison Committee has revised the DAR/SAR Membership Award which recognizes the efforts of DAR members in recruiting new SAR members. The award, first authorized in 1990, is made to DAR state societies with the greatest number of referrals. There is now a two-track system: one uses a leveling formula for the highest percentage of applications that include the DAR Finder Form versus the number of applications adjusted for the number of members in the state society; the other uses the highest number of approved SAR members using the Finder Form. There are six total awards totaling \$1,200.00, with competition from January 1 to December 31 annually. The key element is that the DAR Finder Report Form (DAR FF 11-2017) must be completed and submitted with the application. This is an area in which the Florida Society continues to fall short compared with other states. In addition to the national competition, each chapter should be recognizing the contributions of DAR ladies who are making referrals of new members to their chapters. Recognition may include certificates of appreciation and the SAR Medal of Appreciation, depending upon the number of referrals.

# **Commemorative Historic Sites**

- A proposal has been submitted to the NSSAR Historic Sites and Celebrations committee to designate the annual Battle of Thomas Creek celebration as a recognized National Event. A total of five proposals for new national events will be considered by the committee during the upcoming Leadership meeting in Louisville KY September 19-20, 2019. Committee chairman Bill Sharp has forwarded copies of proposals to each committee member for review in advance of the meeting.
- Three of the proposals have received support from all members responding (Battle of Red Bank, NJ; Battle of Brooklyn & the Maryland 400; and Battle of Princeton, NJ) with some concerns expressed by two members on our Thomas Creek proposal and substantial concerns about the "Washington-Rochambeau National Historic Trail Event in 2021" held by many members. Clarification has been provided on what is desired from SAR on the Trail Event (abbreviated W3R-NHT) and support is likely, though not as an annual event but rather as a one-time commemoration of the 240th anniversary of the event. Further information has also been provided regarding the Thomas Creek commemoration's evolution and present support, and most concerns have been withdrawn.
- A brochure has been prepared and is ready for publication announcing the 243rd Anniversary of the Battle of Thomas Creek on Saturday 10:00 a.m. March 28, 2020 in Jacksonville. An impressive program of speakers and guests are lined up to participate.
- The date (March 7, 2020) for the Last Naval Battle Celebration at Merritt Island has been announced by Compatriot Barry Eller who was in Sweden at the time he responded. More details are expected on this event after his return.
- A meeting was held in Pensacola in an effort to get the annual Battle of Pensacola celebration back on track and to reassure NSSAR that this should retain its designation as a "National Event". The last significant SAR celebration had been held in 2009, and the continued recognition by NSSAR was in jeopardy. Lee Popham and I drove out on August 15th and held a meeting that evening which included NSDAR VPG Ginger Poffenberger, State Regent Kay Yarbrough, Pensacola Chapter Regent Theresa Friday along with PG Lindsey Brock, RVP Matt Mathews, Pensacola Chapter President Chris Washler and other SAR members who had been involved in earlier celebrations. On Saturday, Wesley Odom past Pensacola member and owner of Go Retro tour company took participants on a tour of areas that are important to the celebration, and reviewed a plan he had developed to restore to event to prominence. While there remains much work to be done, May 9, 2020 has been set for the next celebration of the Battle of Pensacola.

He has been provided some "lessons learned" along with sample proclamations that may be used by City and County governments participating in the celebration. The date and location of this event will be announced.

#### Functions:

- 1. Through the chapters, to encourage Americanism which is devotion and loyalty to the United States, its traditions, its customs and its institutions.
- 2. To encourage chapter participation in Allegiance Sunday programs which are held on the Sunday of the 4th of July, or the Sunday immediately prior to the 4th at which allegiance to the United States is reaffirmed.
- 3. To encourage participation by chapters at the naturalization of new citizens and develop programs which delineate the duties, rights and privileges of all citizens.
- 4. To develop programs of Patriotic Educational Significance for presentation before school, citizen, fraternal, and civic groups. Programs may be of historical documents, or biographical sketches of individuals or groups who had impact on the establishment and development of the United States.
- 5. To administer the Flag Program for the Florida Society to include competition for the rear Admiral William R. Furlong Award to the State Society with the best Flag Program, award and present the NSSAR Flag Certificate to individuals and activities in the name of the FLSSAR, encourage FLSSAR chapters to participate in Flag Day, June 14, ceremonies, and promote respect and honor to the Flag of the United States. Encourage chapters to present the NSSAR Flag Retirement Certificate (NEW) to individuals and activities in the name of the FLSSAR.
- Presentations of certificates can be simple or elaborate. Usually they take only a few minutes with a member introducing himself, talking briefly on the importance of or history of the American flag, explaining the award, and presenting it to the group. Certificates can be presented in an SAR folder, in a frame, or mounted to a plaque. If the certificate is mounted or framed, it is more likely to be put on display rather than stuffed in a drawer. Flag Certificates and the new Flag Retirement Certificates are available from the SAR store for only \$4.
- In July, 2019 the SAR National Society approved a new award: The U.S. Flag Retirement Award. *The award is presented to NSSAR state societies by the NSSAR National Society.*

#### The criteria of the award:

To qualify, one-half of its chapter (sic) and the state society must each present at least one U.S. Flag Retirement Certificate within a one-year period. Special recognition will be given if 100% of the chapters and the state each present at least one U.S. Flag Retirement Certificate within a one-year period. Qualification criteria for the award is to be reported, by the state society, to the chairman of the NSSAR Flag Committee and the National Society. The Flag Committee Chairman will evaluate the criteria and determine the award to be given.

#### The Award:

The first time a state society qualifies for the award, a streamer and a U.S. Flag Retirement Award Certificate will be awarded. Thereafter, each time the society qualifies for the award, a white star and a U.S. Flag Retirement Award Certificate will be awarded. If 100% of the chapters and the state each presents at least one certificate in a one-year period a Certificate of Excellence will be awarded, also.

#### Report Date:

The date that a state society must submit its report for the U.S. Flag Retirement Award is March 1 of each year.

# **Veterans Affairs**

Functions:

The Veterans Affairs Committee has two major areas of responsibility.

- The primary responsibility of the State Chairman and the Regional Vice-Chairmen is to encourage, advise, and motivate the various Chapters (primarily through the Chapter Veterans Affairs Chairman) to:
  - a. Recognize and present War Service Medals and Certificates to veterans within their respective Chapters who have served in the military during a war period.
  - b. Recognize and present Military Service Medals and Certificates to veterans within their respective Chapters who served in the military during peace time.
  - c. Recognize and present the SAR Purple Heart pin and Wounded Warrior Coin to veterans within the Chapter who received the Military Purple Heart during their military service.
  - d. Encourage gifting and visitation to veterans both within the Chapter as well as at local VA Hospitals, clinics, and nursing/private homes.
  - e. Participation in military funerals, parades and other veteran functions/activities. (SAR uniforms should be worn when receiving the colors at the funeral of a homeless veteran when no family members are present.)
  - f. Participate and conduct such other Veterans Affairs as directed by the President, Florida Society.
- 2. The State Chairman and the Regional Vice-Chairmen should encourage the Chapters to participate in the national USS Stark contest. The Veterans Affairs Committee responsibilities include:
  - a. Process and consolidate all applications for the USS Stark Award for entrance into the National Contest.
  - b. Summarize the forms for the State of Florida and submit the summary to the NSSAR USS Stark Chairman.
  - c. Inform the FLSSAR President of the state winner of the contest at the Spring BOG for the presentation of the SAR Flag streamers. (The National winner is announced by the NSSAR.)
- Compatriots, with nearly ¾ of the year gone, now would be a good time to make sure that your records of this year's activities in support of our veterans are up to date. Not only does this ensure that your chapter and the state society accurately report their activities to national, it also helps to identify veterans or activities that we have not yet received the recognition or support that they deserve.
- This year the Florida Society has increased its support of the Missing in America Project (MiAP). This organization helps to locate and identify the unclaimed remains of veterans and their spouses. They then coordinate with the VA to ensure proper internment for them. At intervals, they organize ceremonies at national cemeteries where these veterans and spouses can be interred with the honor and respect that they are due.
- On September 26th of this year, six compatriots from three SAR chapters joined members of several DAR chapters, the Patriot Guard Riders, American Legion, VFW, other veteran and civic organizations gathered with the Missing in America Project at Sarasota National Cemetery for the internment of 17 veterans and spouses from the WWII, Korea, and Vietnam eras. Honors were rendered by a color guard from the Army, Navy, Marines and Air Force as well as a firing detachment and bugler. The SAR members participated as pallbearers during the ceremonies and in the procession to the columbarium.
- Another program that has seen increased participation is Honor Flight. The Honor Flight program provides trips for groups of older veterans who would not otherwise be able to travel to see the memorials in Washington, D.C. that have been erected in honor of their service. When a flight returns, the SAR joins with hundreds... sometimes thousands... of grateful Americans to welcome these veterans home once more. Events attended by SAR chapters in Florida include May 4th in Ft. Myers and June 11th in St. Petersburg.

Coming up are flights into Ft. Myers on September 28th and November 2nd. These events are not just for the color guard. If you have the chance, please come out to help welcome our heroes home.

Lastly, Veteran's Corps Survey Forms and the appropriate supporting documentation should be forwarded to the state Veterans Recognition Committee Chairman, Don Lanman. Completed surveys that meet the criteria published by the state and national societies will be processed quickly and will generate a Certificate of Patriotism to present to our compatriot veterans. Please report presentation of these certificates (and the corresponding medals) to the committee at year's end.

#### 3. Committee Activity:

- a. Veterans Recognition Committee continues to work with Chapters to expand the membership of the FLSSAR Veterans Battalion with Compatriots who served honorably in the armed forces. Chapter Presidents are contacted on a Quarterly basis and encouraged to promote Veterans Battalion recognition within each chapter.
- b. Veterans Battalion Roster has been updated on the FLSSAR web site listing of all Veterans Battalion members.
- c. The committee chairman is reviewing all Veterans Battalion requests within 24 hours of receipt of VB application form with DD-214, and mailing the VB letter and Certificate within 48 hours to the Chapter for presentation.
- d. Chapter Presidents are requested to personally present the Veterans Battalion Certificate along with the authorized Military Service or War Service medal to each approved Compatriot at a chapter meeting. The chapter is encouraged, but not required, to purchase the medal for each compatriot directly from SAR.org.
- e. Chapter Presidents are reminded that the *SAR War Service Medal* may only be authorized for Compatriot veterans with proof of war service directly within a DOD designated "combat area" as noted on their DD-214. Non-combat related military service qualifies for the *Military Service Medal*.
- f. The committee continues to work with Chapter Presidents and the NSSAR Veterans Corps committee to help FLSSAR Veteran Battalion members apply for the NSSAR Veterans Corp recognition.

# **Endowment Trust Fund Disbursements**

In accordance with the Trust document and the policies and procedures of the ETF Distribution Committee, through September 20th 16 chapters have been approved for \$8,430.78. Half of that has been distributed and the balance will be sent out in December. Applications for proper reimbursement for expenses incurred during the fiscal year ending October 31, 2019 will be accepted through November 15th.

Elsewhere in these proceedings, there should be an accounting. The required accounting for the full year will be presented for approval after the end of the calendar year.

On August 12th the Trustees met with Regions Bank, the investment advisor to the ETF and the OBT. They reported performance for the funds in line with the Investment Policy statement promulgated by the Trustees. The Trustees expressed their appreciation for the job done in a difficult environment.

To date I have received requests totally about \$8,500. There's still about \$16,000 available. The ETF year ends October 31 with the filing deadline being Nov. 15. Last year we had 66 requests for \$15,626. Please look through you activities and see what you have done that could help your treasury. Last year we made a few changes to the rules and this year I am going to request a few more. We want to do all we can to encourage outreach programs. Remember a keep to reimbursement is that these monies are only for non-SAR members. I will be having a meeting of all youth activity chairmen at 9 AM on Saturday at the BOM. Please encourage your chairman to attend.
