Web Page Richard Bailey

- o Attending the regional EBM in February, Dr. Scott provided a speech about the web site used by the National Society, the State Society, and some of the chapters in the state and how they all were integrated and could share data, reduce the complications of sharing and transferring data. Our issue with being able to integrate is that we are using a web site program that prevents the integration with the state site. Our system uses the un-compatible data base, 'Weebly' which is basically a show and tell only. The compatible data base is 'Dream Weaver'. With this data base we would be able to attach to the state and have access to all the state date data for our chapter. All the information for awards, reports, registrar and the like can be directly to the state and we would have access to all the Withlacoochee Chapter data. The changeover would be the new web site program and the annual cost of \$140.00 per year vs. \$23.00 per year today. The first year for the new program would be about \$450.00 .
- o Tom Hellem made the motion that the chapter; change the web site program to the Dream Weaver program and Dave Hitchcock amended the motion to add; at the cost not to exceed \$450.00 which includes the first-year fee. Motion was seconded; the vote was taken; and the yea's carried to make the change.
